**Section 4. First aid measures****Description of necessary first aid measures**

### Methods and materials for containment and cleaning up

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). ---

### Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8).
